

PURPOSE OF THE SECONDARY PLAN

The Clair-Maltby Secondary Plan is being initiated in order to comprehensively plan the last unplanned greenfield area of the City.

This area has been identified as requiring a secondary plan to:

- Plan for an appropriate range and mix of land uses to achieve the City's overall vision of a complete and healthy community;
- Establish land use designations that encourage compact urban form to meet the density target for the greenfield area; and to,
- Undertake the necessary related studies to support future urban growth, including a comprehensive servicing strategy for the area.

AN INTEGRATED APPF

The proposed planning approach is a Master Environmental Servicing Plan (MESP) and **Community Plan**.

This approach allows the City to integrate all planning studies with the Environmental Assessment (EA) process in order to reduce time and cost in the long term. Studies that will be conducted concurrently through this study include:

- Environmental
- Servicing
- Transportation
- Land use
- Parks, trails, etc.




CLAIR-MALTBY STUDY PROCESS


Visioning for the Clair-Maltby Secondary Plan

- the inclusion of parks and open space.




