4	Must possess a current certificate from TSSA that an inspection has been carried out and that the appliances and vehicle are acceptable to be operated.			
5	The appliance serial number is in a visible location and legible for inspectors.			
6	The appliance manufacturer name is clearly visible and legible for inspectors.			
7	If the vehicle contains provisions for deep frying with cooking oils, it must contain a charged portable fire extinguisher with a class K rating or a class 20BC or higher rating			
8	In addition to the requirements for deep frying a vehicle must contain a portable extinguisher with a minimum class 2A10BC rating			
8.1	All extinguishers have been subjected to maintenance within the past 12 months by a qualified person			
9	The venting equipment for grills, fryers, burners or other open cooking appliances is installed to NFPA 96 – Standard for Ventilation Control and Fire Protection of Commercial Cooking Operations.			
10	Fixed extinguishing systems installed for grills, fryers, burners or other open cooking appliances are installed to NFPA 96 – Standard for Ventilation Control and Fire Protection of Commercial Cooking Operations.			
10.1	Inspection tag is affixed to the fire protection/exhaust systems showing the last inspection date and that the inspection was conducted within the last 6 months by a qualified person			
11	Cooking appliances have been cleaned and are free of grease build-up or food remnants			
12	Owner, operator or other workers on these mobile vehicles are knowledgeable in the use of portable fire extinguishers, manually activating the fixed extinguishing system if it fails to discharge and exhaust system operation
