Matters Arising from the Minutes

Item 5.1 15 and 19 Wyndham Street North (Petrie Building)

Kirk Roberts (owner) and Allan Killin (architect) provided a brief introduction to the conservation work plan being proposed for the Petrie Building and 19 Wyndham Street North. The presentation reviewed the methodology and materials most pertinent to Heritage Guelph. Allan Killin informed that the Jos Quintek system of a micro fine particle vortex would be tested for use in cleaning off heavily soiled areas on the metal façade. He also reviewed the drawings and significant changes as permit amendments, including the new storefront plans. Allan Killin told the committee of their plans for rear alterations, including insulation and cladding of the rear exterior walls and part of the north fourth floor exterior wall as they would like to expose the stone walls on the interior. He explained that insulating from the outside protects the extant, painted parging and the stone beneath from the frost cycle. HG went in committee to discuss the proposed wall claddings.
